#### Results of unitholder meeting

Australian Unity Funds Management Limited (AUFM) ABN 60 071 497 115 AFSL 234454 is pleased to confirm that at the unit holder meeting held 2 December 2024, unit holders passed the resolution that AUFM retire as the responsible entity of the Altius Green Bond Fund and that Australian Ethical Investment Ltd ABN 47 003 188 930 AFSL 229949 (AEF) be appointed as responsible entity in its place. ## What happens next?

ASIC will update their register, so that the Fund's responsible entity is effectively changed from AUFM to AEF. From the date at which this occurs, units in the Fund will begin to be issued by AEF. A Product Disclosure Statement and Target Market Determination will be made available via the website altiusam.com/funds/green-bond-fund.

A Transition Services Agreement is in place for a period of up to twelve months from the <u>completion of the Transaction</u> for AUFM to provide back and middle office support and services to AEF as part of its induction of the Fund, with a view to facilitating a smooth transition of responsible entity functions following completion and ensuring minimal disruption to unitholders.
